सारांश

भाषावैज्ञानिक लेखनात अपरिचित भाषांतील उदाहरणांची छाया देणे ही एक अनिवार्य गोष्ट आहे. त्यासाठीच्या संक्षेपांचा संग्रह ह्या आज्ञासंचात करण्यात आला आहे. इंग्रजी छायांगांचे संक्षेप [leipzig](#) ह्या आज्ञासंचामार्फत पुरवले जातात. लायप्चिश् विद्यापीठाच्या नियमावलीनुसार लागणाऱ्या अनेक निकषांची पूर्तता ह्या आज्ञासंचातर्फे केली जाते. मराठी भाषावैज्ञानिक लेखनाकरिता छायांगलेखनाचे नवे नियम मुंबई विद्यापीठाच्या संकेतस्थळावर [येथे](#) देण्यात आले आहेत [१]. त्यांचा विचार करून हा आज्ञासंच घडवण्यात आला आहे. ह्या आज्ञासंचात काही छायांगांच्या तयार आज्ञा आहेतच, शिवाय लेखकांना गरजेनुसार नवी छायांगे निर्माण करण्यासाठी एक आज्ञादेखील आहे. [hyperref](#) हा आज्ञासंच वापरत असाल, तर छाया हा आज्ञासंच त्यानंतर वापरा.

99. RELICENSING
